9. Continue discussion on housing in the City of Baker - landlords and tenants and adding homeowners (Bryant)

Council Member Bryant announced the No Eviction Order has been extended until January 31, 2021. She wanted everyone to be aware that evictions are happening despite the extension.

10. Discuss residents blowing leaves in Groom Road resulting in blocked drainage (Dunn)

Council Member Dunn initiated discussion regarding leaves and debris being blown into Groom Road resulting in blocked drainage, saying she would like to find a solution to the problem. Council Member Bryant stated there is an ordinance that prohibits this. The Mayor stated the City will get the ordinance out there, so residents are aware this is not allowed. He said enforcement is key and asked that the community help with enforcement by saying something if they see something. The Mayor said citizens can contact the Code Enforcement Officer, as well as law enforcement, for assistance.

11. Progress report on Azalea Trailer Park (Dunn)

Council Member Dunn reported there are several trailers in the park that do not appear to meet code. She also reported that remodel work is being done in the park and asked if these individuals had been to the City prior to beginning the work. Code Enforcement Officer David Georgetown stated he has sent out the initial letters and taken pictures at various addresses in the park. He said progress has been made. Mr. Georgetown said the owners asked for and have been given additional time. He stated the next step is to send certified letters and have the Building Official inspect the properties. Mr. Georgetown said he plans to return later in the month. The Mayor told Council Member Dunn that the City could provide her with a weekly update.

12. Discuss how the City of Baker can play a part in getting Baker High School rebuilt (Dunn)

Council Member Dunn stated having the high school rebuilt is extremely important for the City of Baker. It is her belief that a better school system benefits everyone and improved schools act as an incentive for people to make their homes in the City of Baker. The Mayor said the City can continue to bring business here, which helps create sales tax, thus helping the schools to grow. He also suggested increased community and parental involvement through the PTO, as well as communication with school board members.

13. Update on speed bumps (Dunn)

The Mayor stated after speaking with Chief of Police Carl Dunn, they realized speed bumps are not going to solve all the problems the City has with people speeding. He said speed bumps are extremely expensive to install and maintain, and the City needs to explore other alternatives at this point. He said this is a conversation he will continue to have with the Chief of Police.

- 14. Discuss City of Baker employees being put on vaccine list (Dunn) The Mayor said getting the COVID-19 vaccine is the employee's decision/responsibility. He said if there is an opportunity to offer City employees the vaccine it will certainly be done.
- 15. Discuss the resurfacing of the walking path at City Park (Dunn)
 The Mayor stated the estimate they received totaled \$200,000.00 to complete the project.
 He reported that a total of 107 walkers participated in the survey regarding resurfacing the walking track 69 respondents voted for a rubber surface, 34 respondents voted for a concrete surface and 4 respondents voted for a gravel surface. The Mayor said the City plans to get other estimates and to look for funding for the resurfacing project.
- of Councilman Vincent's Friendly Neighbor Keeper Initiative (Vincent)

 Council Member Vincent expressed his desire to get neighborhoods more involved in bringing a stop to the turbulence and violence in the City of Baker. He said embracing the Friendly Neighbor Keeper Initiative would help embed the principles Jesus taught regarding being concerned for your neighbor in the minds of all our citizens. Council Member Vincent stated he wants to continue discussions about neighborhood watch programs, homeowner's associations, crime prevention districts, and the task force elements aimed at keeping the City of Baker safe. He wanted everyone to know the Council is very concerned, and they are watching in their neighborhoods. Council Member Vincent said we want friendly, safe neighborhoods where residents can thrive. He encouraged everyone to participate in the work session scheduled for Friday, January 15, 2021 and the Town Hall Meeting scheduled for Tuesday, January 19, 2021. Council

Member Vincent said he looks forward to input from all citizens at the upcoming events.

Council Member Bryant said she has established neighborhood captains in District 3. She explained captains are responsible for speaking with neighbors about what is going on in the neighborhood and reporting relevant information to law enforcement. By looking out for neighbors and their homes, neighborhood captains serve as a deterrent to certain individuals who may not want to move into an area if they see a strong neighborhood watch program. Council Member Bryant said every resident has a responsibility to report what they see. She said failure to do so results in a bad situation becoming worse.

NON-AGENDA ITEMS

Ramona Garror, 4805 Sprucewood Court, expressed her concerns regarding her neighbor's dogs. She stated the dogs are not being properly cared for and are often running loose. Ms. Garror also stated the yard has trash all over and a foul odor as well. She is pleading for help to rectify the situation. The Mayor said the Code Enforcement Officer will come out and assess the situation so that any/all appropriate letters can be sent to the homeowner. He also advised Ms. Garror to contact Animal Control. Council Member Vincent stated this is the first he has heard of this situation, but assured Ms. Garror that the issue would be addressed.

Trandra Scott, 1025 Barrington #B, asked if the City has considered putting up surveillance cameras, along with signs to let the public know the area is under surveillance, in Heritage Court. She suggested the City work with the various owners to have cameras installed. She also asked the City to enforce its trash can ordinance. The Mayor said Heritage Court is a priority and the City continues to address issues there on a regular basis. Council Member Young stated he has spoken with Ms. Scott several times and plans to meet with her very soon. He asked that she participate in the Town Hall Meeting on January 19, 2021 in order to further discuss the needs in that area.

Yolanda Ellis, 13802 Morvant, asked about the sign and temporary building that has been placed on Lavey Lane where the new subdivision is to be developed. She wants to confirm that the property will not be used as a car lot. The Mayor stated it will not be used as a car lot. Ms. Ellis stated developments typically use a model home to conduct business out of. She said the trailer is unsightly. Ms. Ellis expressed her concerns regarding drainage and the pipe installation on this property. She said thus far the work is not in keeping with what neighbors were told when the property was purchased. Ms. Ellis stated residents in the area were told the pipe would be run all the way to the canal and covered, this has not been done. She wants verification that the developers intend to complete the drainage work prior to beginning construction of the subdivision. She also feels the newly created ditches are too steep and unsafe. Council Member Vincent said after speaking with Ms. Ellis he contacted Kevin Gravois with PEC. Mr. Gravois indicated that the ditch is so steep because there may not be a pipe placed there at this time. Council Member Vincent said he is working with Ms. Ellis and doing all he can to address her concerns.

Michael Willis, 1002 Shilo, thanked Chief of Police Carl Dunn, Mayor Waites, Council Member Brenda G. Jackson, and Council Member Robert Young for their actions. He said he appreciates the City Council and he thanked the Baker Police Department for their presence in Heritage Court.

Council Member Vincent assured Ms. Scott that Council Member Young will take care of her, as he always takes care of his constituents. He announced January 17, 2021 is the third Saturday of the month and asked that everyone participate in clean-up efforts in their neighborhood. Council Member Vincent wished everyone a Happy New Year and reminded them to be safe.

Council Member Dunn reminded everyone to wear your mask, practice social distancing and wash your hands.

Council Member Bryant asked if the City has received the final report from the LSU Coastal Sustainability Studio. The Mayor stated he has not received the report. She also inquired about funds for the Community Garden. The Mayor asked that she call him so they can discuss funding the project. Council Member Bryant asked if any progress has been made on finding a location for an office to handle veteran affairs. The Mayor said nothing further has been done due to the pandemic. She also asked about the feasibility of loaner computers for council members. The Mayor said the City provides cell phones and internet service to council members and reiterated council members receive a monthly expense account to be used for such items.

He also thanked Council Member Brenda G. Jackson and Chief of Police Carl Dunn for all their dedication and hard work. Council Member Young stated he feels all these individuals would be valuable additions to the Task Force on Community Safety.

Council Member Jackson concurred with statements made by Michael Willis and Council Member Young. She said it is a pleasure to work with everyone. Council Member Jackson said her motto is – Teamwork Makes the Dream Work.
