Council Member Bryant read the mission statement. She announced the CDC has extended the eviction moratorium to October 3, 2021. Council Member Bryant said LaTonya Rounds holds Zumba classes on Tuesdays and Thursdays at 6:00 p.m. at 14412 Plank Road.

5. Update on community garden (Bryant)

Council Member Bryant stated the community garden needs a spokesperson and she is that person. She said the Mayor stated the current garden site is not good, a sentiment she disagrees with, and asked the Mayor if an alternate site has been found. The Mayor said he will confirm the location of the new site by the end of the week. He asked Council Member Bryant to call him to discuss the situation. Council Member Bryant stated she would prefer all discussion be held at the meeting and on the record. She asked that all council members be notified by email once the community garden's new location has been confirmed.

6. Discuss recently signed contracts (Bryant)

Council Member Bryant stated she was contacted by the City Administrator regarding this agenda item. Council Member Bryant said she requested a list of those contracts where the City has entered into an agreement and is dispensing funds. The Mayor said the contracts will be emailed to council members in the morning. Council Member

Bryant said reviewing the contracts helps her make decisions regarding the fiscal matters of the City.

- 7. Discuss plans to clean canal in Parc Chaleur subdivision (Jackson) Council Member Jackson stated she spoke with the Mayor and former Public Works Director regarding plans to clean the canal, at which time the Public Works Director said the City did not have the equipment necessary to complete the work and the job would have to be contracted out. Council Member Jackson said she mentioned the situation to the Mayor again shortly after the current Public Works Director was appointed. She said she is concerned about overgrowth and erosion at this site and asked the Mayor what the City plans to do about cleaning the canal. The Mayor said this is Bozeman Creek and it is being addressed through HMGP. Council Member Jackson thanked the Mayor and said she would pass the information on to her constituents. She stated this is a reminder of the discussion held three or four years ago regarding cleaning the canal.

Council Member Vincent said he continues to receive complaints regarding trash pick-up. Council Member Vincent stated the Baker School System opened yesterday and asked everyone to consider joining the Baker Bikers Club to support the Baker High School football team.

Council Member Dunn announced the Mobile Workforce Center will be in Baker at City Hall on Wednesday, August 11, 2021, from 9:00 a.m. to 4:00 p.m. She asked everyone to support the event. Council Member Dunn reminded everyone to stay safe, wash their hands, and get vaccinated if at all possible.

Council Member Bryant said a company whose business it is to pick-up garbage can not have an excuse that there is too much garbage to be picked-up. She said trash has to be picked up – period. Council Member Bryant asked when the contract with Republic Services is up. She feels it may be time to consider hiring another company to handle the City of Baker's garbage removal. She asked the Mayor what the City planned to do for this year's 9/11 commemorative event. The Mayor stated he had no plans for an event, but, as always, he would support any plan she put forth. Council Member Bryant expressed her extreme displeasure with the way the administration operates, citing a non-existent community garden and no plans for a 9/11 commemorative event as examples. She stated it is not about City Council members or the Mayor, it's about the citizens of Baker, and they should come first – always.

Council Member Young announced the Chamber of Commerce is hosting a Back-to-School Bike Ride on Sunday, August 15, 2021, at Jefferson Street Park. He said line-up is at 5:30, the ride begins at 6:00 and will end at City Park. Council Member Young asked everyone to offer their condolences to City of Baker School Board member Charlotte Booker for the recent loss of her mother.

Council Member Jackson said she will pass on the information from tonight's meeting to constituents. She then initiated discussion regarding the resumption of in-person council meetings. Council Member Jackson said she has heard from numerous residents who feel they do not have the best representation and feel it is time to resume meeting at City Hall.
