**CALL TO ORDER** – Mayor Waites presided.

The invocation was given by Mayor Waites.

The Pledge of Allegiance was led by City Attorney Fabre.

**DISPOSITION OF THE MINUTES OF PREVIOUS MEETING**

The motion was made by Council Member Vincent, seconded by Council Member Young to correct the minutes of the previous meeting.

Council Member Vincent said in the last meeting when there was a reference to the charter and whether or not the Mayor could place an item on the agenda or introduce an item, the City Attorney, Mr. Fabre, explained and stated, for the record, that the mere appearance of the Mayor's name on the agenda in support of any ordinance does not constitute the Mayor's introduction or voting on an ordinance. Council Member Vincent stated he wanted that to be part of the minutes, the same, therefore not in violation of the Baker charter or any ordinance or law whatsoever. He said he wants this to be clear in the minutes because he did not see it and it is very important that it be there because of the item that was discussed thereafter. Council Member Vincent said he did not want any ambiguity in terms of what the City Attorney said and the instructions he gave, and he wanted that to be reflected in the minutes.

Discussion regarding the agenda item was held.

Mrs. Wiltz, Debra Drive, stated that according to the Secretary of State the business is not in good standing for failure to file an annual report. She asked why the business is not in good standing.

Ms. Robinson, owner of Trinity Image Beauty Salon LLC, cited personal reasons as to why the report has not been filed.

City Attorney Fabre stated the Secretary of State issues that form annually, and it is just requiring an update as to whether or not anything has changed and if it is not filed back within a few days it will note that it's not in good standing, it does not have any inference whatsoever as to the legitimacy of the business operation. He said it's simply an update filing, an annual filing that needs to be done that costs about \$20.00 or \$30.00. City Attorney Fabre stated it shouldn't affect the favorable recommendation that's been given by the Planning and Zoning Committee.

Mrs. Wiltz said the item should not be voted on given that the owner has stated the business's annual report has yet to be filed with the Secretary of State. She said if the business is not in good standing it should not be approved.

City Attorney Fabre said the Council makes the decision, furthermore they have no problem with approving what's on the table, which is simply the favorable recommendation from Planning and Zoning. He said once that's done the owner still needs to go to the Finance Department to receive the actual license and he is certain the folks upstairs will require that that be presented to them, but as far as the business plan that is what the Planning and Zoning folks are doing.

The Mayor asked that this item be tabled until the meeting scheduled for Tuesday, December 7, 2021. He asked that Ms. Robinson have all requisite paperwork with the Secretary of State completed before the next council meeting.

He said the City Clerk is taking notes and of course the new minutes from today's meeting should also reflect that the Council voted to make that amendment to reflect that.

Council Member Bryant read the mission statement. She reminded everyone there are currently two proclamations to allow citizens to have a community garden in the City of Baker. Council Member Bryant stated she spoke with Entergy regarding the streetlights on Groom Road near McHugh Road and was told they would be repaired by November 11, 2021. However, the lights are still out. A resident reported they were told by Entergy that the City replaces the bulbs in the streetlights. Council Member Bryant said she sent emails to Administrative Officer Angela Machen and Ms. Reese in the Public Works Department regarding this issue as well. She plans to monitor the situation closely until the streetlights are repaired. Council Member Bryant asked for an update on when the street sweeper is going to be repaired, as it would be helpful in removing the debris left behind by Republic Services. Public Works Director Timmie Sept said they are waiting on the part they need to fix the sweeper.

#### **NON-AGENDA ITEMS**

Ikeal Davenport, 3341 Chamberlain, asked City Attorney Fabre what the City's ordinance says concerning food trucks on Main Street.

City Attorney Fabre said that particular issue is being looked at by a task force that was just recently appointed, so he is not in a position to render a legal opinion. He said there is nothing definitive in the ordinances that specifically prohibits such. They have to apply for a business license just like any other license and go through that process. He said he is part of the task force, and they are supposed to meet to explore that, a business license is a business license, the ordinances do provide, in general, in such a way where such is not specifically prohibited.

Mr. Davenport expressed his concerns regarding the food truck on Main Street and the owner's seeming disregard for City ordinances and procedures.

Discussion regarding the food truck on Main Street, food trucks in general and City ordinances governing such establishments was held.

Council Member Dunn stated she plans to bring this issue back to the Council for consideration after the first of the year. It is her hope that a clear and concise ordinance regarding food trucks can be adopted at that time.

The Mayor stated the task force plans to begin looking over the ordinance next week. He said the Council can legislate what they want, it is up to them.

Council Member Bryant said she wanted to inform the task force that they need to contact DEQ. She stated the building has consistently been cited for several violations over the years and is due for another inspection. Council Member Bryant said if there are any questions regarding what the inspector is looking for or what the violations are, contact Andy Messina at 225-219-3678. She said she has spoken with Mr. Messina and the building has been condemned and there are currently violations at this address.

Mrs. Wiltz asked if there were going to be any citizens appointed to the task force.

The Mayor stated there would be citizens on the task force.
