Anyone applying for a business in the City of Baker may acquire an application online at www.cityofbakerla.com. Be sure to include a Detailed Business Plan with application before turning it in.

You MUST contact the City of Baker Inspection Department to determine if the physical location of your business meets all zoning requirements for the nature of your business.

Applicant will be notified for attendance at a regularly scheduled Planning and Zoning Commission Meeting. Upon positive recommendation, Applicant will be notified for attendance at the next regularly scheduled Council Meeting.

Once approved by Planning & Zoning Commission and the City of Baker Council, Applicant will provide payment to the City of Baker Finance Department, along with the completed checklist, for issuance of license. Acceptable forms of payment include check or money order.

If business is home based, applicant MUST get a home occupation permit as well.

License Fees:

\$50.00 fee for occupational/business license - 1st year in business; Subsequent years based on tables
\$100.00 fee for home occupation permit

******PLEASE NOTE:**

All licenses and home occupation permits are renewed annually.

Forms cannot be filed electronically.

Licenses will NOT be issued at the time of payment. They will be mailed once completed or someone may call you when it's ready for pickup.

***Be sure checklist is completed and signed by designated officials
to obtain license from Finance Department***
