- B. To provide a safe environment through communication with each other & law enforcement Police and Fire Departments.
- C. To provide all neighborhoods with a sense of pride & integrity.

Council Member Bryant said anyone in need of assistance with establishing a garden at their home should contact her at (225) 773-7135. She announced LaTonya Rounds, Holistic Fitness, has added a 7:00 p.m. low-impact class to her schedule. Classes are held at the gym on Alabama Street. She announced the Fire Department has smoke detectors to distribute for residents that need them. She thanked the Baker Police Department for their visibility in District 3, saying we need this in our community to ensure residents remain safe. Council Member Bryant asked that the resident at 4320 Wimbish be given special consideration regarding notices received concerning the state of their property. She stated the individual has been diligent about addressing the issues at this address, but is now extremely sick and has been for some time.

4. Discuss and accept proposed changes to the City of Baker's City Council meeting agenda (Jackson)

Council Member Jackson stated the proposed changes would create a more informative agenda that would better address citizen's concerns and thereby inspire confidence in elected officials.

Council Member Jackson initiated discussion regarding the proposed changes to the City of Baker's City Council meeting agenda.

NON-AGENDA ITEMS

Alteen Profit, 1957 Hovey, addressed the City Council saying she has never seen council members that were so disrespectful and angry, getting nothing done. She reminded council members they work for the citizens, the community, and said she is tired of this, that it is ridiculous. Ms. Profit stated council members need to work together. She also stated residents on/near Hovey Avenue do not want property in that area rezoned.

Mrs. Wiltz asked if the City of Baker has thought about lanes for bicycles. The Mayor stated the city has a bike/pedestrian plan in place for every road that is redone.

Council Member Vincent stated earlier comments regarding council members do not apply to him. He said being elected is a sacred trust and he is honored to represent the citizens of Baker. Council Member Vincent said he has always tried to serve in an efficient and professional way and during his tenure the Baker City Council has had many accomplishments. For example, he has provided Baker students with thousands of dollars' worth of school supplies over the years. Council Member Vincent announced his Friendly Neighbor Keeper initiative will be city-wide Saturday, March 19, 2022, from 9:00 a.m. to 11:00 a.m. with participants scheduled to meet at City Hall. He reminded everyone to continue participating in the initiative every third Saturday of the month by picking up trash in neighborhoods, as well as throughout the city and surrounding areas. Council Member Vincent presented the Mayor the Proclamation of Condolences for the Honorable Judge Christopher R. Dassau presented by Justice of the Peace Tracy Batieste-Wood and her staff at last month's memorial service.

Council Member Dunn stated she is willing to work with all her colleagues for a better Baker. She said she is always striving to be a better person and looking for solutions to problems, that her goal is to help citizens in the community. Council Member Dunn said council members must be persistent and do the foot work. She said council members must put their differences aside and work together.

Council Member Bryant wished everyone a happy International Women's Day. She read the following quote from Booker T. Washington, "A lie doesn't become true, wrong doesn't become right, and evil doesn't become good just because it's accepted by the majority." She asked again for an explanation of the charge on resident's DEMCO bill that says City of Baker. Keba Coleman, Director of Utility Billing, said the charge is a tax put on the bill by DEMCO. It is not a charge from the City of Baker. Council Member Bryant said she has suggested factories for semi-conductors be located in Baker. These conductors are used in cars, computers and cell phones and such facilities would provide jobs for residents in the community. She stated wastewater testing for COVID is being done in cities around the country and the results help leaders make educated decisions about moving forward in the pandemic. Council Member Bryant said the rainy season is

here and reminded everyone to be aware and be prepared. She also asked residents to be mindful of trash pick-up days and put trash out as close to these days as possible. Council Member Bryant reiterated her belief that the city's infrastructure can be improved one street at a time. She suggested improving an area's infrastructure when new projects begin in that location.

Council Member Young applauded Ms. Profit for her comments. He stated District 4 expects him to be professional and accountable. He said he has a lot to learn, and he looks to Council Member Vincent as a mentor. Council Member Young said council members must conduct themselves like leaders.

Council Member Jackson said it is always a time to do what's right. She reiterated that nothing is personal. She asked her colleagues and the listening audience to know we won't always agree, but she will advocate on behalf of the people of Baker. She said she does not believe in micro-management and that she does communicate. Council Member Jackson stated she believes in accountability, transparency and integrity for elected officials.

Council Member Jackson left the meeting due to an emergency.
