Drew Cotten, PEC, provided an overview of the proposed MoveBR Groom Road project.

Recognize Sandra Hally for four years of freedom from domestic violence (Bryant) Council Member Bryant recognized and celebrated Sandra Hally for her four years of freedom from domestic violence. Council Member Bryant said Ms. Hally will also be recognized at the Legend Awards in October.

Council Member Bryant read the mission statement. Council Member Bryant provided a list of various locations/organizations that function as food sources for those in need in the Baker community. She suggested contacting the Food Bank, so they might come to the city as well. She announced Zumba classes are held on Mondays and Wednesdays at 6:00 p.m. at the gym on Alabama Street and said they provide an opportunity to exercise as well as bond with your neighbors. Council Member Bryant thanked the police department for their outstanding service on July 4th. She reminded everyone hurricane season is here, and it is important to keep all ditches and drainage clear of debris. She reiterated the importance of having carbon monoxide detectors in homes using generators during power outages. Council Member Bryant asked Chief Pease if every business in the city has been inspected by the Fire Department. Chief Pease stated every business in the city goes through a pre-fire plan inspection and fire safety code inspection once a year. She asked for an update on the situation at the house on McHugh Road which was overrun with squatters. The Mayor stated they have been removed.

Ikeal Davenport, 3341 Chamberlain, asked Chief Pease to elaborate on what "water" meant in relation to improving the city's fire rating. He also asked if the city's fire department has an adequate number of firemen. Chief Pease said the work being done at the well on Mississippi Street and the proposed water well on Groom Road will resolve any "water" issues affecting the city's fire rating. He also stated the Mayor has allowed the fire department to hire three new firefighters.

Council Member Vincent thanked the Mayor and his staff for cutting the ditches and asked that they not forget Thomas Road.

Council Member Dunn announced a work session on issues facing today's youth is being held Saturday, July 16, 2022 at Shady Grove 1st Missionary Baptist Church located at 16443 Plank Road from 8:30 a.m. to 1:00 p.m.

Council Member Bryant asked that the overgrown lots in District 3, many of which have been reported previously, be cut. She asked when blight court would be held. The Mayor said July 14, 2022. Council Member Bryant again reported that the ditch across the street from Park Ridge Academic Magnet School on Groom Road is overgrown. She reported that the hole next to the sidewalk near 2415 McHugh Road has still not been repaired. Council Member Bryant encouraged everyone to participate in the LYNX program and reminded them that the service is free through the month of July. She thanked Pastor Alexander for giving the invocation at tonight's meeting. She asked the Mayor again to have the area around the well on Debra cleaned up, saying it looks like a junk yard. Council Member Bryant stated there are a lot of streetlights out all over the city, and this is another of the many issues that are continually talked about and seemingly never resolved.

Council Member Young thanked Linda Perkins, CATS board member, for her quick response to the reporting of issues. He expressed his concerns regarding businesses cutting their grass and blowing the clippings into the street. Council Member Young stated as he rides his bicycle at night, if he sees a streetlight that is out, he makes a note of the address and reports the outage.

Council Member Jackson reported that burning is taking place at 5414 Lavey Lane. She thanked the homeowners of Meadows of Chaleur for inviting her to their meeting on Saturday, July 9, 2022. She said she was also very grateful to be able to attend the City of Baker recreation event held at Jefferson Street park. She thanked Senator Regina Barrow and Representative Barbara Carpenter for hosting the District 15 community meeting last night.

Council Member Dunn asked that everyone pray for Chief Dunn and his family.

The Mayor said the LYNX program has been successful so far.

The Mayor provided an overview of COBRA – City of Baker Recreation Association.

The Mayor reminded everyone that if a contractor cuts down a tree on your property, you are responsible for having the debris removed.
