## **CALL TO ORDER** – Mayor Waites presided.

## PLANNING AND ZONING MATTERS

## **NEW BUSINESS**

1. BREC Superintendent Corey Wilson to speak about park and recreation updates in the Baker area (Mayor)

Due to the power outage at City Hall resulting in tonight's council meeting being held virtually, the Mayor asked BREC Superintendent Corey Wilson to give his presentation at the next council meeting. Mr. Wilson did speak briefly, answering Council Member Vincent's question regarding BREC's property along Lavey Lane.

2. Update on quality and fair housing in the City of Baker for all tenants, landlords and homeowners (Bryant)

Mission Statement

A. To provide a healthy lifestyle through community gardens and exercise availability.

B. To provide a safe environment through communication with each other & law enforcement – Police and Fire Departments.

- C. To provide all neighborhoods with a sense of pride & integrity.

  Council Member Bryant read the mission statement and stated it is meant to build a strong, resilient, and productive community. Council Member Bryant announced they are ready to start on the community garden at the First United Methodist Church and asked the Mayor for assistance in preparing the site for planting. She stated that anyone struggling, whether it be with suicidal thoughts, drug or alcohol addiction, any type of mental illness, can call 988 for help. This number is for families of those in need of help as well and can save a life. Council Member Bryant said once again there are problems with Republic Services and garbage pick-up all over the city. She stated she has reported the issue to the Mayor and his Administrative Assistant. She said when dealing with contracts such as the one the city has with Republic Services, it is important to make sure the city is getting its money's worth.
- 3. Discuss proposed subdivisions in the City of Baker (Bryant) Council Member Bryant asked for an update on the subdivisions on Lavey Lane and Sunshine Road. The Mayor stated work is being done at both locations. He suggested she call the builders/developers in order to get specific answers to questions posed by her constituents. Council Member Bryant asked that contact information for both developments be sent to all council members. She stated she has been asked about the work being done on Baker Boulevard as well. Council Member Bryant said residents need to know what's going on in their community, they need to be informed, and that is why she is asking.
- 4. Discuss what is old business and what is new business for the agenda (Dunn) Council Member Dunn asked that this item be tabled.
- 5. Mr. Ed Bush to give a presentation on the American Red Cross (Jackson) Council Member Jackson stated Mr. Bush plans to reschedule his presentation for a later date.

## **NON-AGENDA ITEMS**

Council Member Vincent asked about the possibility of using the 1.1 + million-dollar credit the city is to receive from DOTD as part of the Lavey Lane road transfer for sidewalks along Lavey Lane. The Mayor stated the ultimate goal is to have a sidewalk on Lavey Lane from Highway 19 to Sunshine Road. Council Member Vincent asked if the city is currently working to have the iron structure on Groom Road, the former Rose's Florist, torn down as it is unsightly. The Mayor said they are trying to find someone to purchase the property. Council Member Vincent reminded residents and business owners that this is their city and encouraged them to continue doing all they can to keep their property up. He reminded everyone of the importance of taking pride in their city. Council Member Vincent thanked the Mayor and city employees for keeping the grass cut.

Council Member Bryant asked the administration to address the problem with homeless people at 2511 McHugh Road. She said they have moved the trash from the front yard into the house and have put up their tents in the back yard. She asked that the overgrown lots in District 3, many of which have been reported previously, be cut. She expressed her concerns about inmates being brought to Jetson. Council Member Bryant stated high grass and junk vehicles can become a public safety hazard by offering inmates a place to hide should they escape. She said this is more motivation to clean up the city and she is concerned for citizens' safety.

Council Member Young thanked the residents of District 4 for their patience and understanding. He also thanked Republic Services for doing their job. He explained a route in District 4 was recently missed because the driver of the truck was shot at. However, Republic Services had a truck out the next day to complete pick-up on that route.

Council Member Jackson asked for an update on the canal in Parc Chaleur subdivision, saying work on the canal was scheduled to go out for bid two years ago. The Mayor stated the city tries to cut the canal once a year. Council member Jackson asked for an

update on the building on Plank Road that was placed there without proper licensing or permitting. The Mayor said it is being worked legally.
