Council Member Dunn voted no on allowing Council Member Jackson to abstain, saying the Mayor's name being associated with the agenda item is no reason to not vote.

Council Member Bryant voted yes to allow Council Member Jackson to abstain, saying all council members have the right to abstain and to be treated with respect.

Council Member Young voted no on allowing Council Member Jackson to abstain.

Council Member Jackson voted yes to allow her abstention.

The motion to allow Council Member Jackson to abstain passed with a vote of 3-2.

Council Member Jackson abstained from voting on the introduction of Ordinance 2022-15.

The motion to introduce Ordinance 2022-15 passed with a vote of 4-0.

2. Update on quality and fair housing in the City of Baker for all tenants, landlords and homeowners (Bryant)

Mission Statement

- A. To provide a healthy lifestyle through community gardens and exercise availability.
- B. To provide a safe environment through communication with each other & law enforcement Police and Fire Departments.
- C. To provide all neighborhoods with a sense of pride & integrity.

Council Member Bryant read the mission statement. Council Member Bryant announced they are ready to start on the community garden and asked for volunteers to assist in preparing the site for planting. She stated exercise classes are held regularly at the gym on Alabama Street. Council Member Bryant reminded everyone we are in the middle of hurricane season and suggested that residents take pictures of the items in their homes. She said these photos are invaluable in assisting with filing claims should residents suffer a property loss. Council Member Bryant said she is looking forward to being able to use the city's street sweeper, as this equipment would help keep the city's streets clean and facilitate debris removal. She stated she asked about the street sweeper a year and a half ago and was told the city was waiting on a part.

#### **NON-AGENDA ITEMS**

Council Member Vincent announced September is Sickle Cell Anemia Awareness Month and asked for the city's participation in an effort being put together by the Lions Club – a blood drive scheduled for Friday, September 2, 2022, at the Baker Branch Library from 2:00 p.m. to 6:00 p.m. He announced Ryan's Run will be held Saturday, September 3, 2022. Council Member Vincent asked everyone to consider donating blood for this worthy cause. He thanked the Mayor and his staff for cutting the ditches and reminded them to not forget Thomas Road. Council Member Vincent thanked the business on Main Street for removing the tires from their property. He reminded residents and business owners that this is their city and encouraged them to continue doing all they can to keep their property up. He reminded everyone of the importance of taking pride in their city and thanked everyone for all they do in an effort to keep Baker beautiful.

Council Member Dunn said she enjoyed the recent LMA conference, and she learned a lot, most importantly was that to be a leader, you have to learn how to follow. She said she is praying that the Baker City Council can come on one accord. Council Member Dunn stated people have to put their differences aside, come together and unite in order to grow the City of Baker. She said she spoke with BREC Superintendent Corey Wilson about summer camps and a recreation center for the children in our community. Council Member Dun reiterated the importance of the council learning to work together and doing what needs to be done for their constituents. She said the city's leaders must be unified – not divided.

Council Member Bryant stated being on one accord does not mean you always have to agree, she said it is about respect and serving your community. She said she has no problem with any individual. She said she has a problem with evil – she does not like lies, manipulation, deception, and corruption. Council Member Bryant stated she will not be a part of it, will not represent herself with it or align with it.

Council Member Young said the LMA conference was good, and he was able to spend a lot of time with the Mayor. This time spent afforded him the opportunity to see how much respect the Mayor received from others from all over the state. Council Member Young stated the conference allowed him to learn from those around him, something that is paramount when trying to better yourself personally and professionally. He commended those who regularly attend council meetings and their desire to make the city better. Council Member Young said Saturday's back-to-school event held in the Municipal Auditorium was great, and he hopes the event only grows larger every year.

Council Member Jackson announced a rezoning request for 20+ acres on Lavey Lane will be addressed at the Planning and Zoning Commission meeting on Thursday, August 11, 2022 at 5:00 p.m. in the council chambers. She said anyone unable to attend this meeting can attend the council meeting on Tuesday, August 23, 2022 at 6:00 p.m. when the matter will come before the council for their consideration. Council Member Jackson said she is looking forward to meeting with BREC administrators on Thursday, August 11, 2022 at

9:00 a.m. at the zoo. She thanked the Rotary Club of Baker for inviting her to their event on Thursday, July 28, 2022. She thanked the Zachary and Baker High School classes of 1972 for inviting her to their 50<sup>th</sup> class reunion on Friday, July 29, 2022. Council Member Jackson thanked Dr. Katina Brooks for the back-to-school giveaway on July 30<sup>th</sup>.

Adam Kwentua, candidate for District Court Judge – Section 2 – Division G, introduced himself and presented his platform.

The Mayor discussed the city's emergency response plan, saying we must be able to take care of ourselves when disaster strikes. In an effort to help make the city more self-sufficient in times of crisis, the police department has purchased a high-water rescue vehicle and the fire department has purchased a search and rescue boat.

Council Member Vincent asked again about the possibility of the city acquiring a backhoe with a long arm to help clean out canals and ditches in an effort to alleviate flooding.
