#### **NEW BUSINESS**

1. City of Baker duplication of benefits policy (Mayor)

LaTania Anderson stated FEMA requires the city to have a duplication of benefits policy in order to be in compliance and continue to participate in their programs. She provided an overview of the proposed duplication of benefits policy.

Discussion followed.

Council Member Jackson asked to meet with Ms. Anderson regarding the policy to address her questions and concerns. She stated she did not feel comfortable voting on the policy at this time.

2. City of Baker procurement policy (Mayor)

LaTania Anderson went over FEMA's requirements as they relate to the proposed procurement policy and explained that while the city currently has a procurement policy, FEMA requires certain language be included in order to be in compliance and continue to participate in their programs. The proposed policy would satisfy those requirements.

Discussion followed.

Council Member Jackson asked to meet with Ms. Anderson regarding both policies to address her questions and concerns. She reiterated she did not feel comfortable voting on either policy at this time.

3. Update on quality and fair housing in the City of Baker for all tenants, landlords and homeowners (Bryant)

Mission Statement

- A. To provide a healthy lifestyle through community gardens and exercise availability.
- B. To provide a safe environment through communication with each other & law enforcement Police and Fire Departments.
- C. To provide all neighborhoods with a sense of pride & integrity.

Council Member Bryant read the mission statement. She stated it is time to start planting green, leafy vegetables that will keep you healthy. Council Member Bryant said communication is extremely important, it keeps the community safe. She reminded everyone – if you see something, say something. She said it is important for citizens to realize we are a village and deal with one another in a respectable manner. Council Member Bryant said efforts to beautify the city are important. Things such as keeping yards cut, removing inoperable vehicles, picking up trash and litter, not only benefit residents, but they also raise the community's standard. These things enhance the look of the city as well, which in turn can help attract businesses.

1. Proclamation declaring April 2023 National Autism Awareness Month in the City of Baker (Vincent)

Mrs. Miranda Georgetown Riley, The Magnolia Rose Foundation, to speak about Autism Awareness Month

Mrs. Georgetown-Riley provided a history of the Magnolia Rose Foundation for Autism Acceptance. She said in order to fund and support the mission and vision of the foundation, they have to solicit donations, sponsors and have fundraisers. She said the foundation hosts two major fundraisers every year – The Rose Run and the Magnolia Ball

Mrs. Georgetown-Riley announced the Magnolia Sneaker Ball will be held Saturday, October 21, 2023. She said the ball helps fund the foundation's monthly playdates, which are held at different venues each month and are completely free for participants. This month's playdate is being held on Saturday, March 25, 2023, at Jefferson Street Park and will feature a petting zoo and horseback riding.

Mrs. Georgetown-Riley announced the second annual Rose Run will be held Saturday, April 22, 2023, at City Park and this year's theme is a Color Run. The event will feature prizes, a raffle, a vendor village with food for sale as well as resource vendors, a children's sensory lane with learning activities for all children, facepainting, and a DJ. And, as April 22<sup>nd</sup> is Magnolia Rose's actual 4<sup>th</sup> birthday, there will be free birthday cake for all.

Council Member Vincent expressed his admiration for all that Mrs. Georgetown-Riley and the Magnolia Rose Foundation for Autism Acceptance has accomplished. He encouraged everyone to do as he has done and support the foundation and its efforts.

City Attorney Fabre read the proclamation declaring April 2023 National Autism Awareness Month in the City of Baker.

The Mayor reported the trailer across the street from the Fire Department on Groom Road has been removed.

#### **NON-AGENDA ITEMS**

Council Member Vincent referenced the blue star on his lapel and said it stands for colorectal cancer awareness, as March is Colorectal Cancer Awareness Month. He said Chris Davezac asked for a list of places that need to be addressed by Barber Brothers and he has his list compiled. Council Member Vincent stated he would provide a copy of the list to the Mayor and Public Works Director Timmie Sept as well. He reminded everyone about the city-wide cleanup day being held Saturday, April 22, 2023. Council Member Vincent announced the Baker Chamber of Commerce is hosting a golf tournament and asked anyone interested in participating to contact Michel Woods. He thanked the Mayor and Public Works Director Timmie Sept for addressing the concerns he and his constituents had with the development on Lavey Lane.

Council Member Dunn thanked the Mayor for recognizing her and said her primary purpose is to serve the community, the city, and her constituents. She said she would like to see the council come together and support and work with the Mayor to get things done in the city. Council Member Dunn stated she is trying to have a community center built in the city and she continues to encourage parents to come out and register their children for BREC's summer camp. She said they are working with the City of Baker Foundation and actively seeking donors to help pay a portion of BREC's camp fees for six children from the Baker community.

Council Member Bryant announced the nail shop formerly located next door to Baskin-Robbins is relocating to the old Capital One building on Main Street. She asked that the bumps on Groom Road and Baker Boulevard be addressed because both are a safety issue and pose a hazard to vehicles. Council Member Bryant stated she is passionate about economic development in the City of Baker. She said working together as a council is getting ideas out to businesses and having conversations with them that promote their interests and inviting them to join the community. Council Member Bryant said the city is big enough and diverse enough to support all types of businesses, no business is out of reach. She stated the city must conduct business according to the law and initiated discussion regarding the city's cease and desist procedure.

Council Member Young thanked Council Member Dunn for taking up all of his time. He said he had his grandbaby today for the first time and he is worn out.

Council Member Jackson thanked the residents of District 5 for communicating their concerns regarding road repairs. She said the repair work has been successfully completed. She said she will continue to ride the district and report areas of concern. She said members of any board or body must learn to respectfully disagree. Council Member Jackson said, "You can not control what happens to you, but you can control your attitude towards what happens to you, and in that, you will be mastering change rather than allowing it to master you."
