She asked again about mandatory CPR classes for city employees and having a defibrillator at City Hall. Council Member Bryant stated the importance of having a plan in place for active shooter incidences at area schools as well. She said pride and integrity are important and it is imperative that neighborhoods continue to improve so that the city can move forward. Council Member Bryant said the city is big enough and diverse enough to support all types of businesses,

businesses both big and small, and the city needs to attract businesses that can provide a tax base that will support the school system. Council Member Bryant stated she wants to see the city move forward and that it can move forward, she said we must raise our standards and level of expectations.

Gretchen Wiltz, Debra Drive, in honor of Women's History Month, recognized the female council members. She recognized, Council Member Rochelle Dunn – District 2, Council Member Glenda Bryant – District 3, and Council Member Brenda G. Jackson – District 5, each of them for being a Woman of History in the City of Baker. She also presented City Council President Glenda Bryant a certificate of appreciation for her outstanding community outreach services.

Council Member Vincent reminded everyone the second annual Rose Run for autism acceptance is being held Saturday, April 22, 2023. He also reminded everyone the citywide cleanup is being held that same day. He thanked the Mayor, Public Works Department and Chris Davezac for having dirt placed in various locations following the road overlay work. Council Member Vincent stated he had several questions for the Mayor, questions which were asked at a meeting held last night. He asked if the city has a city engineer, other than PEC. The Mayor said Chris Davezac. Council Member Vincent asked that the City Council be notified when the city hires new personnel. He asked the Mayor if the city has additional plans for drainage throughout the city, over and above what has already been done with the rescue money. The Mayor said yes, and asked Council Member Vincent to come by so they can go over the drainage plans. Council Member Vincent stated again that the city-wide cleanup will be Saturday, April 22, 2023. He encouraged his colleagues to form teams to work their districts and asked that everyone, businesses and residents, participate. Flyers are available in the lobby.

Council Member Dunn said she is very excited about the city-wide cleanup. She said she will be at the state Pilot Club convention that weekend, but she is assembling a team and they are excited about the event. She announced registration for BREC summer camp will be held Saturday, April 1, 2023. She said in order to have a camp at the BREC gym on Alabama Street, there must be 50 children registered. Council Member Dunn encouraged parents to come out and register their children for camp. She said it's about the children and she wants them all to be safe and have a good summer.

Council Member Bryant said the city needs businesses that will provide activities for the children in our community. She said it is very important to have something for kids to do in the summertime, so they do not get into mischief. Council Member Bryant asked what the Baker Foundation is. The Mayor stated it is a 501(c)(3), a charitable organization whose mission is to have funds go through there for the schools and the kids. The Mayor said they have a board. Council Member Bryant asked for a list of the foundation's board members. She invited everyone to the United Family Worship Center, 2024 Main Street, on Friday, March 31, 2023, at 7:00 p.m. to celebrate Pastor Jeffery Haynes and his wife Vermonica Haynes on their 10-year Pastor's Anniversary. Please call 225-719-6909 for information regarding tickets. Council Member Bryant asked if the City of Baker has an emergency fund for the utility company. The Mayor said state law prohibits the city from setting up an emergency fund such as that. However, he did say the city works with residents during holidays and natural disasters. Council Member Bryant asked if Chris Davezac has a degree in engineering, and if he is licensed. The Mayor said yes. Council Member Bryant asked about the city's procedures regarding bank deposits. Finance Director Mary Sue Stages said the deposits are brought to the bank by a police officer, and explained that any city employee who handles money is covered by the city's bond.

Council Member Young announced that tomorrow at 5:00 p.m. Baker Heights Elementary is having a book fair and asked everyone to support their efforts.
