3. Update on quality and fair housing in the City of Baker for all tenants, landlords and homeowners (Bryant)

Council Member Bryant read the mission statement. She said many area residents have gardens and she asked that they contact her at 773-7135 if they need any assistance. She announced the city plans to place exercise equipment in the park and this will enhance exercise availability in the city. Council Member Bryant stated she has heard police visibility in the community has been low and she wanted everyone to know the police

department is in the process of hiring new officers. She said she has received reports that both children and adults are going to the vacant property on Burgess. Council Member Bryant reminded everyone of the importance of taking pictures of the inside of your home and your belongings for insurance purposes, as we are entering hurricane, rain and flood season. She said such documentation is invaluable should disaster strike.

4. Reading of Attorney General's letter (Bryant)

Council Member Bryant read the letter she received from the Attorney General's Office regarding her request for an opinion on City of Baker Ordinance 2010-11. She explained that the Attorney General's Office will not render an opinion on this matter at this time due to pending litigation.

Sheila Anderson, 4504 Fausse, asked for information regarding the canal that runs behind her property in Meadows of Chaleur subdivision.

Public Works Director Timmie Sept stated the city is in the process of acquiring land

from property owners in the area so that the city can address the situation.

Discussion followed.

Council Member Vincent said he attended the Love the Boot press conference yesterday and procured a plethora of information. He also said this is Love the Boot week in Louisiana and provided an overview of the in-depth report he received from the state regarding littering in Louisiana. He reminded everyone about the city-wide cleanup being held on Saturday, April 22, 2023, and encouraged everyone to take part in this effort. Council Member Vincent also encouraged everyone to participate in his Friendly Neighbor Keeper initiative held on the third Saturday of every month in a continued effort to keep Baker beautiful.

Council Member Dunn thanked Chief Dunn and Chief Pease for going to Rolling Fork, Mississippi, and everything they did there. She thanked David with Sno Biz for serving hot dogs, and everyone who contributed and made donations. She said another tractor trailer will be leaving tomorrow morning, going to Silver City, Mississippi, to deliver disaster relief supplies. She thanked the Mayor for giving her the opportunity to be of service to another city. Council Member Dunn said the council needs to learn to come together and not attack one another or the Mayor. She went on to address issues and concerns she has with Council Member Bryant. She reiterated how difficult it is to work with colleagues who persist in promoting negativity.

Council Member Bryant responded to the concerns expressed earlier in the meeting and said she does not believe in bullying, but in doing things the proper and respectful way. She reiterated that she respects everybody's opinion and their vote. Council Member Bryant stated she is on the council because she loves the City of Baker, and her purpose is to serve its citizens. She said as we respect each other, there is no reason to attack each other. She said engaging in such activities distracts city leaders from dealing with issues vital to improving the city and moving forward. Council Member Bryant closed with a quote by James Baldwin, "It is certain, in any case, that ignorance, allied with power, is the most ferocious enemy justice can have."

Council Member Young commended Council Member Dunn for all she has done as a newly elected council member. He said it's not always easy, but he encouraged her to keep pushing through. Council Member Young suggested that council members institute a policy that would limit their speaking time under Non-Agenda Items to five minutes. He said any more than that is a dissertation and simply wasting people's time, anything more than five minutes is just a show. In response to Council Member Bryant's comments prior to the invocation, Council Member Young also suggested that a prayer box be placed outside the council chambers, so that the items placed in the box could be prayed for during the council meeting's invocation.

Council Member Jackson said following the council meeting last week where she expressed her concerns regarding the City of Baker Community Foundation, she conducted further research, and was able to talk to Angela Trahan. She asked Chief Pease if the Baker Fire Department is still participating in the Baker Charitable Foundation's bingo. Chief Pease stated he could not answer that question, as the Baker Fire Department has never been involved with bingo. He suggested Council Member Jackson contact the president of the Fireman's Union Ronald Brady and/or the Baker Volunteer Fire Department Social Club. Council Member Jackson stated she requested, via email, a copy of the recently filed federal lawsuit involving the City of Baker. She said the request was made on April 12, 2023, and as of today, she has not received the information she requested. She respectfully asked the City Attorney to provide her with this information.
