CALL TO ORDER – Mayor Waites presided.

The invocation was given by Council Member Vincent. The Pledge of Allegiance was led by Council Member Young.

Council Member Bryant read the mission statement. She announced Zumba classes are being held at the gym on Alabama Street and that daytime classes have been added as well. Council Member Bryant warned residents that individuals are trying car doors and reminded them to lock their cars and to not leave any valuables inside. She reported that several fire hydrants in District 3 need to have the weeds around them removed. Council Member Bryant said keeping up your yard and other property is a source of pride and integrity in the community. She asked that everyone be mindful of their neighbors and reminded residents that on street parking is prohibited in the City of Baker.

ADMINISTRATIVE MATTERS

The Mayor said it is that time of year again, when there is an increase in out of cart trash and brush piles, when the grass is growing and being cut at a pheromonal rate, when ditches need to be cleared and maintained, and trees are being pruned and cut down. He asked that residents do all they can to assist with keeping their neighborhoods and the city clean in the coming months.

The Mayor stated they would be picking up the pace with the removal of junk vehicles throughout the city.

The Mayor asked everyone to get involved, volunteer, and commit to working together to build a stronger community.

NON-AGENDA ITEMS

Sheila Anderson, 4504 Fausse, expressed her concerns to Council Member Jackson regarding the representation being provided to the residents of District 5.

Morris Anderson, 4506 Fausse, initiated discussion by asking who is responsible for maintaining the ditches if it's not the city's responsibility. Mr. Anderson expressed his concerns regarding grass cutting, ditch maintenance and the removal of debris once a tree has been pruned or cut down.

Council Member Vincent asked about the status of Millennial Park subdivision. The Mayor stated the city is waiting on submission of necessary paperwork. Council Member Vincent thanked the Mayor for having the snowball stand, the abandoned building, on Plank Road removed. He asked about the status of the property on Blairstown as well. The Mayor said the property is adjudicated and cannot be torn down. Council Member Vincent asked the Mayor to look into the house right off Alabama Street with the blue tarp on the roof, as residents have expressed concerns.

Council Member Dunn said she is asking all local businesses to participate in and support the 2023 back to school event being hosted by Community Partners, the City of Baker, the City of Baker School System and Baker City Council members Dunn, Vincent and Young. The event will be held on Saturday, July 29, 2023, from Noon until 4:00 p.m. at the City of Baker School System office located at 14750 Plank Road. Council Member Dunn asked that the community come out and support the children.

Council Member Vincent stated his annual District 1 back to school giveaway is on Saturday, July 22, 2023. However, he wanted Council Member Dunn to know he will make a donation to the event being held on July 29th, as will the Baker Lions Club.

Council Member Bryant congratulated Walmart on the state of the store during her last visit, saying the floors were clean and the aisles free from boxes. She said raising standards affects the prosperity of the community. She encouraged everyone to strive to embrace a healthy lifestyle and advocated for having a hospital located in the City of Baker. She said there is a need for more minority doctors to service minority communities. New Beginning Baptist Fellowship Church had a health fair last Saturday and attendance was low. She said the city has to do better with letting citizens know what is available to them. Council Member Bryant reported the Debra Street well and surrounding area is a mess and asked that the situation be addressed immediately. She asked that the city do everything it can and work with the developers of Millennial Park subdivision to see the project completed.

Discussion regarding Millennial Park subdivision was held.

Council Member Young continued the Millennial Park subdivision discussion by stating he has not seen a swale at Millennial Park subdivision and the ditches at this site are not deep enough. He commended the Public Works Department for their hard work in

District 4 and expressed his sincere appreciation for all they do. He thanked the fire and police departments for all they did on Saturday when the tree was blown over on Alabama Street. Council Member Young reminded everyone he still holds the record for the largest back to school event held in Baker.

Council Member Jackson thanked the parents of Dr. Amber Jarrell for the outstanding job they did raising their daughter. She said it was a privilege and an honor to learn about Dr. Jarrell. Council Member Jackson closed with the following quote, "Letting people be wrong about you or a situation while keeping your peace and focus is the most misunderstood power move you will ever make."

Council Member Bryant asked if it is necessary to own a home in the City of Baker in order to serve on the Baker City Council.

Finance Director Mary Sue Stages provided an explanation of the auditor situation as it relates to Mr. Akanji. She said Mr. Akanji is working as a consulting partner on the audit.
