Council Member Bryant read the mission statement. She stated the city will have a community garden in the future. # **NON-AGENDA ITEMS**

Kenneth Wackett, 14305 Felicity Drive, stated recycling has not been picked up in Feliciana subdivision for a month. He asked what day recycling is supposed to be picked up in his neighborhood. The Mayor said recycling should be picked up on Friday. He did, however, say that Republic was having some issues. Mr. Wackett expressed his concerns regarding the trash behind Dollar General and asked who he needs to contact to have the situation addressed. The Mayor assured Mr. Wackett he would have someone there tomorrow.

Morris Anderson, 4506 Fausse, read a statement expressing his opinion of behavior exhibited at the council meeting held on September 12, 2023. In his opinion, certain council members were unprofessional and an embarrassment to the city. He feels that business and industry are not attracted to the City of Baker because of disorganization and confusion on the council.

Sheila Anderson stated her opinion regarding the representation of District 5 on the Baker City Council.

Council Member Vincent stated he will address Mr. Wackett's concerns as soon as he

returns. He thanked Council Member Jackson for attending the health screening he held several weeks ago and for placing the announcement for the event on Facebook which helped to reach more participants. He thanked all his colleagues for their continued support of his initiatives and programs. He asked that everyone join the Council Member Vincent's Friendly Neighbor Keeper initiative and pick up trash in and around their neighborhoods every third Saturday, or more often if possible. He thanked the Mayor and Public Works Department for fixing the water leak at the corner of Alba and Anton. Council Member Vincent thanked Big Boy Food Mart for cutting their grass and picking up trash in the area. He also stated he is grateful for the work being done by Walmart to enhance the store inside and out. Council Member Vincent reiterated that he consistently does all he can, whether it be picking up trash himself or encouraging businesses to maintain their property, to keep Baker beautiful.

Council Member Dunn apologized to anyone she may have offended. However, she said she will continue to voice her opinions and she will speak when it's her turn to speak. She said it is never her intention to disrespect anyone or the City of Baker and reviewed some of the duties incumbent on members of the Baker City Council. Council Member Dunn said council members have got to learn to work together, they must come together in unity to move the City of Baker forward.

Council Member Bryant stated she considers herself a lady, but she has the right to speak, and she will. She said Mr. Edwards, 4504 Greenwood Lane, has been waiting for assistance with a sewer issue for nine months and at this point he feels as if the city has abandoned him. She said they attended a ribbon cutting at the Executive Suites hotel on Highway 19 and the owner asked that business be sent his way. She reiterated economic development is paramount to growth in the City of Baker. Council Member Bryant said there is a tremendous amount of bullying and disrespect that goes on at council meetings and it's not pretty. She said she has never been a part of anything like it, but she has a first amendment right to defend herself.

Council Member Young thanked the Public Works Department for the job they're doing fixing water leaks that have been reported and asked that residents continue to report any water leaks they see. He announced Rilei Douglas was voted Miss Baker Heights Elementary School and asked that everyone give her a big round of applause.

Council Member Jackson invited everyone to Barbara's Block Party for District 63 on Saturday, September 30, 2023, from 3:00 p.m. to 6:00 p.m. in the Scotlandville Plaza. Council Member Jackson said she believes no matter what a person has to say, they are entitled to say it, she was raised that way and will continue to live by that. She said she feels that sometimes saying nothing is the best course of action and before you argue with someone, ask yourself is that person even mentally mature enough to grasp the concept of a different perspective, because if not, there is absolutely no point.
