### **PUBLIC MEETING**

### **ADMINISTRATIVE MATTERS**

The Mayor announced the City of Baker received the Healthy Communities Grant, a program designed to support local projects and programs that will bring about behavioral changes needed to improve, and protect the natural beauty of Louisiana. The grant will allow the city to utilize cameras that will aid in combatting illegal dumping by capturing photos of the person and their vehicle which seek to illegally dispose of garbage.

### **NON-AGENDA ITEMS**

Dr. Toni Jackson, 931 Husband Street, stated she has been contacted regarding the upcoming election. Ethics, political signage, and candidate residency were some of the concerns expressed by residents. Dr. Jackson said the City of Baker does not need negative publicity and asked that all candidates run a good race.

Joslyn Jackson, 1585 Davis, expressed her concerns regarding the lien placed on her property by the city. Ms. Jackson stated she paid to have the debris removed after the limbs were cut on her property. She said she received no letter, no notification and when she asked the city for a copy of what was sent to her, they were unable to provide that information. Ms. Jackson stated she wants the lien removed from her property.

Discussion regarding the City of Baker's code enforcement process, ordinances, notices, and blight court followed.

Richard Jackson stated he received a letter regarding his Blazer, a vehicle that is insured. Mr. Jackson said it is as if the city is targeting their neighborhood. He said residents in their neighborhood are having liens put on their property without receiving notification, receiving letters about violations that are questionable and are being given the wrong information. He said something must be done, it has to stop.

Discussion regarding the City of Baker's code enforcement process, ordinances, notices, and blight court resumed.

Council Member Vincent recommended residents organize a homeowner's association to better deal with issues that arise in the neighborhood. He stated a constituent expressed concerns regarding the condition of the Walmart parking lot and asked about the possibility of sending Walmart a certified letter detailing the improvements the city would like to see. Council Member Vincent asked that the shrubbery at Greenwood Shopping Center also be addressed, as constituents have contacted him regarding that situation as well. He reminded everyone of the program honoring Dr. Martin Luther King, Jr., being held Saturday, January 6, 2024, from 10:00 a.m. to 12:00 p.m. at the Baker Branch Library. Council Member Vincent announced Ashley's Optical, 13131 Plank Road, will have free food, live music and entertainment, as well as Santa Claus on Friday, December 22, 2023, from 2:00 p.m. to 5:00 p.m. He encouraged everyone to come out and

enjoy this festive event.

Council Member Dunn said homeowner's associations are good, however, older subdivisions often don't have people dedicated to the community. Older residents are often not tech savvy and don't use the internet or social media. She suggested the city produce a flyer containing information regarding city ordinances and what is expected of residents to be distributed throughout the city. She said it is imperative that the city let people know what is expected of them and they should have a plan to reach members of the community. Council Member Dunn wished everyone a Merry Christmas and a Happy New Year and reminded them she is here and willing to help in any way she can.

Council Member Bryant stated some people get their debris/trash picked up while others do not get that same treatment. She said the city's ordinances provide for what should be done and what is expected from residents. She wished everyone a Merry Christmas and Happy New Year. She addressed her colleagues, saying council meetings do not have to be political, and she plans to do her best to remember this in the coming months. She also reported a sewer issue at Azalea Gardens and asked that the city evaluate the situation, as it is unclear who is responsible for repairs at this time. Council Member Bryant asked Council Member Vincent if he received a redistricting map. Council Member Vincent said he has not heard from anyone and has not received any information. Council Member Bryant said she will continue to pursue this issue because it is important. She said it is imperative city leaders and citizens know exactly where the districts are.

Council Member Jackson said notifying residents of expectations should be done by the city's code enforcement officers. She stated she appreciated the comments on the political season and upcoming election made earlier in the meeting. She also encouraged candidates to evaluate their motives, make any corrections that need to be made, withdraw if that's what needs to be done, but run a clean race. Council Member Jackson wished everyone a safe ending and prosperous beginning in the new year.
