She announced the recently opened business on Main Street has programs for children and adults. Council Member Bryant reminded everyone adults must be aware of and responsible for all guns in their household. She reiterated the importance of CO2 monitors and said again that the city should make these available to residents. Council Member Bryant said how we plan to work together is how we work together.
