Council Member Bryant read the mission statement. She suggested growing an herb garden and using them as a replacement for salt to season food. She also recommended regular exercise as part of a healthy lifestyle. She thanked the Fire Department for the AED machine placed at City Hall and suggested having them placed at schools as well. Council Member Bryant asked that a wellness check be done on the gentleman on Gwendolyn with the fallen tree across his house.

10. Update on projects: City of Baker submission on project to state capital outlay for project 573651 (drainage improvement and upgrades) and project 573650 (sidewalk construction) (Jackson)

Council Member Jackson initiated discussion regarding project 573651 and project 573650. She provided an overview of the timeline for these projects, stated that money had been appropriated, and asked why the money has not been drawn down.

The Mayor stated an update on these projects would be given under Administrative Matters.

11. ANNOUNCEMENT: Councilman Charles Vincent's Mwalimu Institute project – "Help us find your house with visible municipal numbers" – still available (Vincent)

Council Member Vincent reminded everyone that his Mwalimu Institute, in conjunction with Entergy, has implemented a city-wide program to provide visible municipal house numbers for Baker residents. One of countless programs implemented by the Mwalimu Institute over the years to help the citizens of Baker. Residents can contact City Hall, their city council representative, the fire department, or police department to participate in this program. Council Member Vincent encouraged all who are in need of visible house numbers, especially the disabled and elderly, to take advantage of this program.

12. Nikki Warden to discuss organizing Neighborhood Watch throughout the city (Young)

Ms. Warden explained that a group of civic-minded citizens is working to establish a citywide Neighborhood Watch organization. She stated they are currently in the planning phase and asked that all interested parties contact her in order to be added to the contact list. Ms. Warden encouraged everyone to consider participating in this worthwhile program.

Council Member Vincent thanked everyone who came out and participated in the Love the Boot citywide clean-up on May 20th. The city's efforts contributed to the 347 tons of litter/trash collected throughout the state during the event. He offered his condolences to the Owens family. Council Member Vincent reminded everyone about his Mwalimu Institute's ongoing house numbers program.

Council Member Dunn suggested that city leaders look into securing grants that would pay to have trees cut down for individuals having problems with trees in their yard. She stated that anyone needing assistance of any kind need only reach out to her and she will do all she can to help.

Council Member Bryant reminded her colleagues that their personal financial disclosure statement is due May 15, 2024. She stated hurricane season is here and suggested that everyone document their belongings in order to facilitate communication with FEMA and/or insurers in the event of damage or loss. She reported a gas leak at 4613 Greenwood Lane, and stated this situation was previously reported. Council Member Bryant asked that the caboose at the museum be painted.

Council Member Young recognized Mr. Sam Boatner.

Council Member Jackson stated she did not know about the contract with Waste Pro and only found out about the town hall meeting from the notice she received in the mail. She said she was grateful that she had the opportunity to attend the meeting, even if only for a short time.
