Drew Cotton, Project Manager – MoveBr Groom Road, provided an update on and highlights from the project. The project has two phases – Phase 1 McHugh Road to Plank

Road with an estimated cost of \$9.5 million and Phase 2 – LA 19 to McHugh Road with an estimated cost of \$10 million. Mr. Cotton reported the final construction plans have been completed (Phase1). He stated once Phase 1 is completed Groom Road will have a new roadway surface, bike and pedestrian lanes, enhanced crosswalks, handicap ramps, new school zone flashers, new CATS bus stop pads, a turn lane at McHugh Road, stormwater system enhancement and will feature beautiful landscaping as well.

The Mayor read the budget message.

8. Update on quality and fair housing in the City of Baker for all tenants, landlords and homeowners (Bryant)

Mission Statement

A. To provide a healthy lifestyle through community gardens and exercise availability.B. To provide a safe environment through communication with each other & law enforcement – Police and Fire Departments.

C. To provide our neighborhoods quality representation of integrity and tenacity.

Council Member Bryant read the mission statement. She provided an overview of her eight-year tenure and various accomplishments as a member of the Baker City Council. Council Member Bryant addressed the gangs terrorizing the city and cautioned everyone to be careful. She reported that she has spoken with the Health Department and the issue with the gentleman on Gwendolyn with the fallen tree across his house is being addressed. Council Member Bryant implored the administration to address blighted properties in the City of Baker, saying that such areas are breeding grounds for rodents and snakes, and pose a health risk for residents as well.

9. Discuss Waste Pro contract (Jackson)

Council Member Jackson stated she did not know the Waste Pro contract had been signed and was made aware of this fact by a non-constituent. She said she only found out about the town hall meeting held at Redemption Life from the notice she received in the mail. She said she was grateful that she had the opportunity to attend the meeting, even if only for the last minute and fifteen seconds. Council Member Jackson expressed her concerns regarding the manner in which the city entered into the contract with Waste Pro, saying proper rules and procedures were not followed. Council Member Jackson stated she believes that the contract should have been brought before the city council for approval prior to being signed by the Mayor. She maintains that historically, contracts and rate increases have been brought before the city council for approval. The motion was made by Council Member Jackson, seconded by Council Member Bryant to have the City of Baker pay the ten-dollar monthly increase to the waste management services for the duration of the Waste Pro contract.

Discussion regarding the Waste Pro contract, the ten-dollar monthly increase, the process in which the city enters into contracts, and the Mayor and Council's respective roles in said process was held.

A substitute motion was made by Council Member Vincent to schedule a work session to discuss the Waste Pro contract.
