He expressed his concerns regarding the proposed ordinance and said he hoped everyone had a chance to look at the documentation he provided relative to said concerns at the last council meeting. Council Member Vincent feels entities seeking a business license should continue to come before the council for approval. He contends this function is a necessary and vital role of the elected officials that comprise the legislative body of the city, a check and balance inherent to our system of government. He asked that the item be tabled so that further discussion can be held.

1. Upcoming community meeting (Dunn)

Council Member Dunn thanked the Public Works Department for all their help and support in District 2. She announced a District 2 community meeting will be held Thursday, March 20, 2025, at 6:00 p.m. at the municipal building.

2. Lavey Lane update, African American History programs, etc. (Vincent)

Council Member Vincent thanked the mayor for the meeting regarding Lavey Lane, Baker Boulevard, and Groom Road and the updates he provided on each project. He stated it has been an excellent African American History Month and thanked everyone for coming out to support those efforts. Council Member Vincent said he received a call regarding the drainage on Longvue, and discussion followed. He stated residents need only call the city in order to get a garbage can or recycle bin and that garbage pick-up is on Tuesdays and Fridays. Council Member Vincent verified with the mayor that the council meeting minutes are posted online, as he was asked about this as well. He stated he spoke with the new owner of the shopping center on Plank Road and all the complaints – the lighting situation behind the buildings, the noise, recklessly operated vehicles – are to be addressed. Council Member Vincent said he has a list of dump sites to be monitored and reminded everyone that cameras, purchased with funds from a Keep Louisiana Beautiful grant, will be placed around the city to help remedy this situation.

Council Member Dunn asked that the lighting on Plank Road be assessed as more streetlights are needed in that area.

Council Member Murphy thanked PEC for completing the project on Rue Jennifer.

ADMINISTRATIVE MATTERS

The mayor stated all seven of the lift station generators have been installed.

The mayor announced the developer has begun phase two of Sunshine Gardens subdivision.

The mayor said construction on houses in Trinity Estates subdivision on Baker Boulevard will begin soon.

The mayor said work should begin on Lavey Lane and Baker Boulevard in March. He said work on Groom Road is slated to begin soon as well.

The mayor said the city will provide utilities for the new subdivision being built at Groom Road and Old Scenic, the plans call for 1,000 houses.

The mayor encouraged everyone to sign up for GovDelivery in order to stay informed and up to date to with city events.

Administrative Officer Angela Machen provided an update on the home rehab program and the Brownfields grant project.
