

ORDINANCE 2025-7
AN ORDINANCE ADOPTING THE OPERATING BUDGET OF GENERAL FUND
REVENUES AND EXPENDITURES FOR THE CITY OF BAKER, LOUISIANA
FOR FISCAL YEAR 2025-2026

BE IT ORDAINED BY THE MAYOR AND COUNCIL of the City of Baker, Parish of East Baton Rouge, Louisiana, in regular session assembled, a proper quorum being there and then assembled, on the 24th day of June 2025, as follows, to wit:

SECTION 1: The attached and detailed estimate of revenues as reflected in the consolidated statement, and such fiscal exhibits and information as required by Section 1308(D), Louisiana Local Budget Act, to the extent that the same are not inconsistent with the Home Rule Charter of the City of Baker, be and the same is hereby adopted to serve as the Operating Budget of General Fund Revenues and Expenditures for the City of Baker, Parish of East Baton Rouge, State of Louisiana for fiscal year July 1, 2025 through June 30, 2026.

SECTION 2: The attached and detailed estimate of expenditures, as reflected in the consolidated statement, and such other fiscal exhibits and information as required by Section 1308(D), Louisiana Local Budget Act, to the extent that the same are not inconsistent with the Home Rule Charter of the City of Baker, be and the same is hereby adopted to serve as the Operating Budget of General Fund Revenues and Expenditures for the City of Baker, Parish of East Baton Rouge, State of Louisiana for fiscal year July 1, 2025 through June 30, 2026.

SECTION 3: The adoption of the Operating Budget of General Fund Revenues and Expenditures for each Budget Unit shall be declared to be the appropriation for each Budget Unit. For more complete information, the line-item detail containing object of expenditures by classifications has been attached.

SECTION 4: Nothing in this section shall be construed to prohibit the governing authority from amending or making an appropriation to and for a contingent fund to be used in cases of emergency.

SECTION 5: That the Clerk of Council shall cause this Ordinance together with the summary of the Operating Budget of General Fund Revenues and Expenditures for the City of Baker, Parish of East Baton Rouge, State of Louisiana for fiscal year July 1, 2025 through June 30, 2026, to be published once in the official journal of the City of Baker, Louisiana.
